Speak Up for Workplace Safety

This seminar is intended to motivate workers and employers to challenge the silence that can lead to unsafe practices and conditions. Talking to the boss or a co-worker about safety can be difficult. This session will help participants understand why there is often a culture of silence in the workplace and learn ways to overcome it, and will demonstrate one communication technique to bring safety issues to the forefront. Strategies for Keeping Young Workers Safe

As an employer, you are aware of your obligation to protect the health and safety of your workers. If those workers include youth, it can be extra challenging to fulfill that obligation. This session offers support to employers and supervisors with youth in their midst, and includes ideas for training and supervision, successful strategies for communicating with youth, and youth resources available to PEI employers. (2 hours)

Respectful Workplace (new!)

The workshop begins by helping participants to understand the underlying factors that influence respect between people and in the workplace. There will be an opportunity for self-reflection during the workshop and plenty of opportunities for questions and discussion. (2 hours)

Workplace Inspections

This session will introduce the 4 safety truths that help improve workplace inspections. Inspections are a planned, comprehensive walk through of a workplace. The goal is to identify potential hazards in a given scenario and be proactive in order to prevent incidents. What to look for and what to do when a hazard is identified will be reviewed and discussed. (2 hours)

Safety Committee Basics

Is your safety committee just getting started? Has it been running for a while but losing its way? Whether you are a new or seasoned committee member, this seminar will address a committee's intended purpose and responsibilities under the PEI *Occupational Health and Safety Act*. Topics covered will include committee duties, meetings, record maintenance, rules of procedure, making recommendations, and measuring successes. Intended for safety committee members. (3 hours)

Hazard & Risk Assessment

The *Occupational Health and Safety Act* requires the employer to inform their workers and supervisors of the hazards at each workplace, and workers have the right to know how to be protected from those hazards. Participants will receive instruction on the steps and goals of hazard and risk assessment and will practice documenting an assessment through a given scenario. (2 hours)

Lifting & Back Safety (new!)

Back injuries are all too common in today's workplaces. Many of these injuries can be avoided if the proper lifting and back health principles are followed. This workshop will help participants to learn lifting techniques that prevent injuries and general back health and safety guidelines. (1 hour)

Due Diligence

This session begins with a thought-provoking video to bring awareness to the importance of adequate training and supervision, followed by sharing of information and experiences, reviewing real life cases and the lessons learned, and applying due diligence principles to help resolve given scenarios.

Participants will learn about their safety responsibilities and how to take a 6-step due diligence approach to help prevent and reduce illness and injury at work. Best suited for those who direct and assign work to others, including employers, owners, directors, managers and supervisors. (3 hours)

Incident Investigation

This seminar will help guide those who are involved in investigations of workplace incidents and injuries. Participants will receive instruction on the common steps used during a workplace investigation. Given a written scenario, participants will identify contributing factors and make recommendations to help prevent a similar incident. (2 hours)
